The pool committee has been diligently preparing for the 2002 season. The committee, with input from the membership, has hired a new management company. Carefree Pools is in the process of changing our filtration system to a salt-water operation. NO more chemical chlorine! The salt system will make our pool a more pleasant "cement pond". Salt water is less abrasive to skin, hair and eyes as well as giving your swimsuit a longer life.

Another difference is the new location for the entrance gate. The new entry gate enters to the backside of the clubhouse. This gate can only be opened with your membership card. This system will record all entries to the pool, thereby allowing us to staff the pool appropriately; membership cards will be available on May 11 and 12th, opening weekend from 10:30 until 12:30. Effective this season the Rivershyre pool will be staffed by Attendants, who are Red Cross certified lifeguards. The pool rules have been updated to reflect this change in operations.
